AIMS OF PERSONAL DATA PROCESSING AND LEGAL GROUNDS	<p>Gospodarstwo Ogrodnicze [Horticulture Farm of] Tadeusz Kusibab reserves the right to record the course of the event as a photographic, visual or audio recording for documentation, educational, promotional or marketing purposes of GOTK. Your Personal Data shall be processed in order to publish promotional materials of Gospodarstwo Ogrodnicze [Horticulture Farm of] Tadeusz Kusibab, pursuant to a recorded course of the event as a photographic, film and sound recording for documentary, educational and promotional, as well as marketing purposes of Gospodarstwo Ogrodnicze [Horticulture Farm of] Tadeusz Kusibab.</p> <p>Your Personal Data shall be processed pursuant to the regulations of the Directive of the European Parliament and Council No 2016/679 of 27 April 2016, with later amendments, on Personal Data Protection of natural persons in connection with processing of personal data and on free transfer of such data, and on repealing Directive 95/46/EC (general directive on data protection), the so called GDPR, for promotional purposes of the event and the Organiser's activity.</p>

TRANSFER OF PERSONAL DATA TO A THIRD COUNTRY OR AN INTERNATIONAL ORGANISATION	Your Personal Data shall not be transferred to any third countries or international organisations.
LENGTH OF TIME OF KEEPING PERSONAL DATA	Participants' Data shall be kept in the Register of Events for an indefinite period of time.
PARTICIPANTS' RIGHTS	You have the right to request access to your Personal Data and rectify or correct your data or the data of your minors' or the persons' under your care.
THE RIGHT TO LODGE A COMPLAINT TO A SUPERVISING BODY	You have the right to lodge a complaint to a supervising body which deals with personal data protection in a EU member country of your permanent residence, place of work or a place of alleged infringement.
THE SOURCE OF PERSONAL DATA ORIGIN	Photographic, visual and audio materials which come from the GOTK's own recordings, recordings of the event co-organisers and widely available press materials.
